Each year since (with the exceptions of 2021 and 2022) we have held this event at Orlando's Event Center, and with the help of our valued sponsors, host committees, and monies raised through raffles, instant buys, and silent and live auctions, we have raised \$1.7 million dollars for our winning charitable organizations.

Any 501(c)(3) charity can be represented through the purchase of a table (a portion of the table purchase is also tax deductible). Every purchased table receives an entry for their charity into a drawing that concludes the evening. Three such charities will be drawn at the 2026 event. The 2025 recipients, Italian Open Golf Tournament for Charities, Aquinas Institute of Theology, and Creative Concepts for Living each received \$43,000 from the generosity of all that attended. 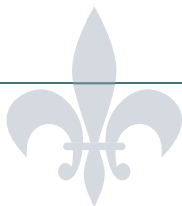
